- ✓ Water is not readily available. If you need water, please bring it with you or indicate your needs in the "Description" line on the form and we will see if we can accommodate your request.
- ✓ Vendors are responsible for trash removal generated by their operation.

SET-UP / HOURS

- ✓ This is a rain or shine event, there is no rain date or refund due to weather.
- ✓ Vendors set-up begins at 11am on June 22, performances begin at 3pm.
- ✓ BY 2:00PM, Vendors MUST remove their transportation vehicles off Michigan Ave to a parking lot.
- ✓ Vendors are allowed one sandwich-board type sign, 6 square feet maximum, during event hours only.
- ✓ Vendors are REQUIRED TO STAY until the end of the event, approximately 11:00pm.

APPROVAL PROCESS

- ✓ Spaces are assigned once payment is received. Maps showing your location and nearby parking lots will be emailed prior to event. Vendor space is limited and distributed on a "first-come, first-served" basis.
- ✓ Questions regarding location on the day of the event should be directed to the Welcome Tent (where t-shirts are displayed, not the beer tent) near the stage, on Michigan Avenue.
